


International Conference On

Guidelines for Submission:

Abstract / Full paper must be submitted through E- mail at: *conference@iumizoram.edu.in* with subject clearly mentioned as Abstract/Full paper along with the corresponding author name.

Abstract

Abstract should not exceed 350 words in length and should include brief introduction, core objectives of the paper, proposed methodology, findings and implications along with key words.

Full Paper

Kindly refer to the following guidelines before submitting your manuscript:

- Submitted manuscripts must not have been previously published, presented, accepted for publication for any other journal or research conference/seminar.
- The entire manuscript (including cover page, abstract, main text, exhibits, appendices and references) should be included in one document.
- The manuscript must be submitted in A4 size pages with double–spaced Times New Roman 12 pitch in MS Word compatible format text.

- The length of the research papers (including exhibit and references) should be between 5000-8000 words. Case studies may be between 2000-5000 words.
- Brief bio-data of the author, passport size photograph, certificate of originality and consent for publication in proceedings should be sent along with the paper.
- All papers will be reviewed by an expert committee with respect to their quality, originality and relevance. Articles will be subjected to plagiarism check before being sent for review process.
